#### Personal Harassment –

#### Abuse of Authority -

Where an individual improperly uses the power and authority inherent in a position to endanger a student's academics, undermine the performance of a student, threaten the student's economic livelihood, or in any way interfere with or influence a students academic career. It is the exercise of authority in a manner which serves no legitimate academic purpose and ought reasonably to be known to be inappropriate.

#### Sexual Harassment -

Any conduct, comment, gesture or contact of a sexual nature, whether on a one-time basis or a series of incidents, that might reasonably be expected to cause offense or humiliation or that might reasonably be perceived as placing a condition of a sexual nature.

#### Poisoned Classroom Environment -

Characterized by an activity or behavior not necessarily directed at anyone in particular, that creates a hostile or offensive workplace. Examples of a poisoned environment includebut are not limited to: bullying, graffiti, sexual, racial or religious insults or jokes, abusive treatment of a student and the display of pornographic or other offensive material.
